**Note:**

- Dyes consumption for deep shade, Steam with 3<sup>rd</sup> wash and Chemical treatment.
- All these 04 (Four) colours are to be printed according to the required percentage of reactive & disperse dyestuff together.
- Design of print must be very clear. Any overlapping, misprinting, bleeding, staining and defect of printing will not be accepted.
- Finishing of cloth must be smooth and soft.

**Special Conditions for Grey Cloth**

- Cloth must be free from all kinds of unevenness, naps, slabs, knots, weaving defects, viscose, rayon, thread missing and foreign materials etc.
- For weaving grey fabric yarns must be manufactured by combing process & must be twisted.
- Selvage must be firm & free from all defects. Loose selvage is not acceptable.

**Special Condition – Combat Printed Cloth**

- a. High quality dyestuff from any internationally reputed company (preferably from Germany and Switzerland) has to be used.
- b. Shade must be as per approved sample held in IGS&C.
- c. Colour fastness bellow grey scale rating 3/4 may be rejected.
- d. Colour/Shade must not be discolored/faded within first 06 (six) months of use. Supplier/ Manufacturer must provide warranty certificate in this regard.
- e. Product should be free from defective/mixed fiber such as Viscose, Rayon etc.

**4. Length of Thaan**

- a. Minimum 50.0 metre each Thaan before inspection.
- b. During 100% inspection, up to 9.90 metre than to be considered as multiple of 3.30 metre. Above 9.90 metre than defective portion has to be marked as rejected without cutting. Final quantity of the than to be counted and marked by deducting the rejected quantity.

**5. Marking (Thaan)**

- a. In case of central procurement name of the supplier, contract no & date, challan no with dt have to be printed clearly on the selvage and it should be printed twice in every one meter (Example: XXXX Ent, Cont. No-XXXXXXXXXXXX Dt. XX Dec 25, Challan-1/26 Dt. XX Jan 26).
- b. In case of local purchase name of the supplier, contract no & date, challan no with dt, **LP by COD** have to be printed clearly on the selvage and it should be printed twice in every one meter (Example: XXXX Ent, Cont. No-XXXXXXXXXXXX Dt. XX Dec 25, Challan-1/26 Dt. XX Jan 26, **LP by COD**).
- c. Both ends of a than to be marked of with 100% inspection's acceptance marks, length of than and the word "SENABAHINI" with indelible ink.
- d. Any coloured stripe near the selvage of cloth will not be allowed.

**6. Packing.** Quantity of each roll is to be 125 to 150 metre and each roll should be packed in the following process:

a. Each than should be rolled on a good quality paper tube and packed in polythene. Then wrapped with hessian cloth such Material: Jute, GSM: 250 ± 5 gm, Type of Weave: Plain, No of Threads/2.54 cm (Warp & Weft): 11/12 nos and B.S in kg (Warp & Weft): 50 kg.

b. One edge of Hessian cloth to be stitched and other edge of Hessian cloth to be tied with twine jute.

7. **Marking (Roll)** One side of the roll to be stenciled with nomenclature of store, contract no with dt, l/note no, date and total quantity of cloth and other side to be stenciled with the name of Consignee, Roll No & Firm/Textile factory's Name.

8. **Samples**

9. **Warranty/Guarantee** The warranty/guarantee period of the store will be 20 (Twenty) months from the issue of Inspection Note' by IGS&C. In this regards the manufacturer/supplier should provide a warranty/guarantee certificate regarding durability of the supplied stores. If supplied stores found defective within 20 (Twenty) months during storage and practical use (Under normal use with standard maintenance) then defective cloth to be replaced by the manufacturer/supplier at their own cost within 30 (Thirty) days as the case arises.

10. **Test Report and Quality Control Certificate by Supplier.** Supplier has to provide fabric/product test report (for tests mentioned at ser 1 - 3) from any reputed testing organization (e.g. Intertek, SGS, Bureau veritas etc) alongwith advance sample and subsequent each challan. Supplier should also certify that they have carried out comprehensive quality inspection at their end and they are fully confirmed and satisfied according to the points as mentioned below along with each challan:

- Products are produced/manufactured as per specification.
- Products are tested/inspected as per the specified tests mentioned in this specification and found correct in all respect.

11. **Special Condition.** There should be an agreement between supplier and manufacturer where supplier will manufacture product from a specific factory (Maximum three factories can be nominated by the supplier to avoid unforeseen situation for which the primarily selected manufacturer or factory owner by the supplier may not be able to run the factory/machineries; i.e natural disaster, unavoidable mechanical failure of machines etc) and submit with Tender. Later the supplier will produce 100% product from the same factory. The supplier must submit one copy of this agreement initially at DGDP. The supplier will submit the final agreement on stamp between supplier and manufacturer to DGDP while contract is being processed with DGDP.

12. Eligibility of Supplier to Participate in Tender

a. Local Agent/Source: Manufacturer/Supplier having the capability and recent experience to manufacture/supply both the Grey and Combat Printed Cloth in Bangladesh Army are allowed to participate in the tender.

b. Local Agent or Supplier of Foreign Agent/Source.

(1) Following certificates from foreign original manufacturer/ factories to be submitted during tender:

- (a) Agreement between local supplier and the foreign original manufacturer/factory.
- (b) Can produce the product as per specification.
- (c) Can produce the required quantity within the schedule time limit.
- (d) Warranty/Guarantee Certificate about the quality and colour of the cloth.
- (e) Foreign Manufacturer's experience certificate.

13. Inspection

- a. 100% inspection will be carried out for all local/foreign contract.
- b. Pre-Shipment Inspection (PSI) will be carried out for foreign contract.




